



STATE-BY-STATE: SECOND PARENT ADOPTION LAWS
 (This chart has required no update since May 2008)

Some states allow individuals to petition to adopt the child of his or her same-sex partner. These are usually called second-parent or stepparent adoptions.

States must honor second-parent adoption judgments from other states. See *Russell v. Bridgens*, 647 N.W.2d 56 (Neb. 2002) (Nebraska must recognize second-parent adoption granted in Pennsylvania even though Nebraska would not have permitted such an adoption); *Starr v. Erez*, COA99-1534 (N.C. Ct App. Nov. 27, 2000) (North Carolina must honor second-parent adoption granted in Washington state); *Finstuen v. Edmonson*, 2006 U.S. Dist. LEXIS 32122 (W.D. Okla. May 19, 2006) (Oklahoma's statutory ban on recognizing adoptions performed in other states by more than one individual of the same sex violates Full Faith and Credit and Equal Protection Clauses of U.S. Constitution).
