# Introduction

Family Equality is a national non-profit organization that advocates for, supports, and provides resources for LGBTQ+ families so that they have the freedom to find, form, and sustain their families. In our effort to be a more inclusive and diverse organization we have created the Family Equity Justice Program. The Family Equity Justice Survey is the research component of this program that will allow us to learn more about how the cycle of family building and sustenance is experienced by BIPOC and/or geographically remote families who live outside of major urban centers. This project seeks to engage participants beyond existing bodies of knowledge to include more alternately-resourced (under-resourced) families and families who live in non-metropolitan areas as highest priority. All of our interactions with partners and participants need to be grounded in Family Equality values of love, advocacy, joy, diversity, equity, pride, courage, and collaboration.

# Target Sample

We want to identify, survey, and interview BIPOC LGBTQ+ caregivers/parents of children of any age that have had at least partial custody of their children during their childhood. The current age of the child is not relevant nor is the race of the child. BIPOC means any parent/caregiver that does not identify as solely white. We would like for at least 50 percent of our sample to be from families that are alternately-resourced and/or living in non-urban areas.

# **Project Scope**

We are issuing a Request for Proposal to potential research partners and consultants to assist us in conducting a literature review, identifying enough of our target population to take



the survey, engage with participants as interviewers/researchers, review and code the data, and interpret the results of the survey in order to share our findings and understandings internally and externally with the goal of increasing diversity and inclusion of perspectives and needs that have not been fully addressed by our organization and our allies in this work.

#### **Project Purpose**

We hope to be able to answer the research questions below and reach around 2000 LGBTQ+ BIPOC and/or geographically remote LGBTQ+ families during the survey process in 2023.

How do the experiences of LGBTQ+ BIPOC families differ in relation to family creation, conception, economic challenges, discriminations faced, religion, child-rearing, partner selection, education, healthcare, identity development, mental health, substance abuse, body image, and relationships with families of origin?

How has being an LGBTQ+ parent or child impacted your relationship with your community and do you feel empowered to pursue your goals and objectives in the current political and cultural moment?

What are the barriers to engagement and participation in the broader LGBTQ+ family rights and advocacy community for BIPOC people and families?

The survey component will be conducted in summer, fall, and winter of 2023. The coding of data and reporting of results will be complete by the end of the second quarter of 2024.
